**Proposed Bylaw changes submitted herein
for Grand Lodge *Proposed by-Law in italics.***

PROPOSED Article III Communications

Section 1. The Stated Communications of this Lodge shall be held on the first Tuesday of each month at 7:30 PM, except the months of July and August.

Section 2. Special Communication may be called at the pleasure of the Worshipful Master, or in his absence by the Senior Warden, or in the absence of both by the Junior Warden.

- *Section 3, The Annual Communications of this Lodge shall be held at 7:30 PM on the first Tuesday of December of each year for the election of Officers and such other business as may regularly come before this Lodge.*

PROPOSED: Article IV: Election of Officers

Section 1. The Election of Officers of the Lodge shall be at the Annual Meeting of the Lodge in December of each year.

The Worshipful Master, Senior and Junior Wardens, Treasurer, Secretary, Assistant Secretary, Assistant Treasurer and Representative to the Grand Lodge shall be elected by ballot,

a majority of votes cast being necessary for choice. The Worshipful Master-elect shall appoint the remaining Officers of the Lodge prior to his installation.

The installation of Officers duly elected and appointed may take place on any date following the Annual Meeting but prior to the next Stated Communication, and shall continue in Office until their successors are duly elected and installed.

Section 2. There shall also be chosen by ballot of the Annual Communication, two Brethren, who with the Worshipful Master and Wardens shall constitute the Committee on Masonic Relief.

Other proposed changes will be included in next month's Trestleboard.
